PUBLIC FORUM

A. Public Forum – for Members of the Public

A parishioner reported that a hedge cutter had cut back brambles outside their property and in the process severed a telephone line, leaving the household without telephone and broadband for three weeks. The Chair has spoken with the hedge cutter to help prevent a repeat. BT has advised that it is unable to access the pole to replace the line at a higher level due to obstructing trees and brambles.

- B. To Receive Reports from the County and District Councillors'
 - County Councillor Judy Cloke sent apologies and a report.
 - **District Councillor Anthony Speca** sent a report and answered questions on the Local Government Reorganisation. The District Council supports a three-district model within the proposed unitary arrangements while Suffolk County Council supports a single unitary model. Mayoral elections are expected in May 2026. A Devolution Committee and an Empowerment Bill will be debated with the Bill proceeding to the Lords for a vote.

6. Village Reports & Issues

a) All Saints

- Cllr Hughes-Jones reported that general encroachment letters had been delivered to parishioners
 around All Saints Common and St Michael's Common. The Clerk advised that two residents had
 contacted her to ask about the purpose of the letters and she confirmed that they were issued to
 provide information on general encroachments.
- Two bollards outside All Saints bus shelter had been destroyed and reported.
- The willow tree will be trimmed; the area is currently overgrown with sedge grasses.
- A water leak has been reported among the reeds. The Chair has notified Essex and Suffolk Water, and it will be repaired.

b) St. Nicholas

- The public highways are in a poor state of repair, with potholes and verges damaged by large vehicles
- Footpath signs around Eels Foots have disappeared.

c) St. Michael

• The SSSI post has been retrieved, repaired and replaced to protect the yellow clover along Uncles Lane. Thanks were given to Dr R Hughes-Jones.

d) St. Peter

- Concern was raised regarding damage to verges in the fields near Low Farm caused by sugar beet lorries and agricultural vehicles. Several roads have deteriorated at the edges, and parishioners have lodged complaints.
- The Water pressure has been very poor. Essex and Suffolk Water reported that the issue is with the pump station, where only one of the two pumps is operational and functioning ineffectively.
- Cllr Patrick and Cllr Hughes-Jones reported on the Suffolk Water Recycling, Transfer and Storage
 Project Winter 2025 Consultation

The project aims to improve regional water security in light of shortages around Eye, expected demand from Sizewell C and future population growth. Water would be taken from the Lowestoft Recycling Centre, treated at the proposed Lowestoft Advanced Recycle Plant and discharged into the River Waveney. It would then be abstracted downstream for further treatment at a new Barsham facility before being piped underground to two new reservoirs near Laxfield and Eye. As an NSIP, decisions will be made nationally. The consultation seeks local insight on land use and conditions along the proposed routes. Route BC2 passes near Spexhall and BC5A near Aldous Corner, Rumburgh and Gray's Lane, Wissett, avoiding the approved solar site before continuing to Chediston. Route BC6 is more direct with fewer listed buildings.

Links to maps and documents have been shared and the Clerk holds copies of the consultation materials.
